School Day Consultation for September 2017

I would like to make all staff, parents and pupils of Mundford Church of England Primary Academy aware that we are currently consulting on some changes that we would like to make to our school day, commencing September 2017. We have been trialling an afternoon without a break. EYFS & KS1 teachers can give the children a break at their discretion but often don't. Most school do not have afternoon breaks and it is widely accepted that a break disrupts learning and results in 47½ hours lost learning time! This has had a financial consequence because Teaching Assistants are not paid for their breaks unless they are on duty, so during this trial period we are paying overtime.

I have already consulted with governors and we have agreed the proposed model which I would now like to share with you to gather your views.

I will explain the rationale behind our suggestions and other considerations.

1. We are proposing to shorten our lunch break by 15 minutes. Younger pupils take longer to eat their lunch and because of pupil numbers we need to stagger the start of lunch. We currently have a very long lunch break when compared to other schools.

Rationale:

Pupils will still have an adequate break that will allow them to take part in extra-curricular activities, and enjoy lunch, but this time reduction will help prevent the loss of focus that some pupils experience with a longer break.

Other Considerations:

Midday supervisors will have their working day shortened by 15 minutes.

Teachers &Teaching Assistants will be asked to return to afternoon lessons 15 minutes earlier. This could incur additional staffing costs for our Teaching Assistants so we will only ask them to start at 1 pm when they are covering teachers' PPA. This will mostly be offset by what we currently pay most staff for their two afternoon break time duties.

2. We are proposing a shorter school day; children will have the same amount of time in class because of the cut to lunch break.

Rationale:

We are often involved in after school meetings with staff at Gooderstone Church of England Primary School or at cluster level. All of these schools end their school day at 3:00 pm or 3:15 pm, so having an end of day that is in line with other schools will help us to engage with these opportunities for professional development.

Other considerations:

Ensure Education Transport is able to collect pupils at 3:15 pm. This action will off-set the current additional cost incurred by no afternoon break for Teaching Assistants.
