



Gooderstone C of E Primary Academy Home School Agreement for September 2020

School will:

- Minimise social contact by ensuring children only mix with the children within their own class bubble (see Mrs Godbold's separate letter for the detailed arrangements).
- Clean communal areas, resources and equipment before they are used by a different class bubble.
- Encourage and monitor regular hand-washing and other hygiene practices with staff and children.
- Isolate and send home any pupils who display symptoms of COVID-19. Take appropriate steps and notify parents promptly in the event of a child, adult or family member testing positive.
- Plan & deliver a recovery curriculum that takes into account the children's different experiences since school closed, with a focus on wellbeing as well as academic subjects.
- Provide regular activity and outdoor learning for children (in all weathers).
- Use class emails to set homework activities that will support the learning within school. Send home reading books and other letters in plastic wallets.
- Adapt teaching styles and lessons to meet children's needs. Maintain a one metre plus distance wherever possible between adults and children, making use of small group work and verbal feedback to support children. Minimise the amount of time adults spend in close contact with children.
- Provide the normal level of care for children who require first aid but with the addition of PPE.
- Use virtual means to involve parents in learning while they are unable to physically enter the school building. Communicate with parents via class emails or telephone calls.
- Provide home learning for the children in the event of another school closure.
- School WILL NOT socially-distance children within each class bubble.

Parents will:

- Communicate with class teachers via the class emails.
- Phone the school office for urgent enquiries or use the myed app or office email for non-urgent enquiries.
- Drop off and pick up children quickly and at the allocated time for each class bubble, remaining outside of the school building at all times and only entering the school site at allocated times.
- Encourage appropriate behaviour of your children whilst at school by modelling the school values of honest, kindness and respect.
- Keep children at home and inform the school if any family member, including the child, has the symptoms of COVID-19.
- Provide your child with suitable clothing and footwear for both indoor and outdoor activities (inc. wearing PE kits on given days).
- Ensure children only bring the allowed items into school (water bottle, packed lunch, coat & reading book).
- In order to support the recovery curriculum, parents will read daily with their children, practise spellings regularly and ensure the children complete any homework activities set.
- In the event of another school closure, parents will follow the home learning and communicate regularly with teachers via class emails.
